1. This result is provisional.
2. The result has been declared based on candidates' Online Registration for the post without any prior screening of their eligibility. Their candidature remains subject to fulfilling the eligibility conditions outlined in the Detailed Recruitment Advertisement (DRA) Notice No. 93/2026, dated 13.06.2026, and any subsequent notices published on the official website.
3. The list of candidates provided is sixteen (16) times the category-wise seats advertised in Notice No. 93/2026 and its subsequent addendums/corrigenda, as per the prescribed scheme of examination. However, inclusion in this list does not guarantee employment for the advertised posts. All tie cases have been resolved as per published criteria. Any tie cases with the last candidate called for Stage-II: Skill Test in respective category have been included in this list.
4. Skill Test will be conducted shortly as per detail published in DRA Notice No.93/2026 dated 13.06.2026, schedule of same will be published separately. Venue details and reporting time for Skill Test will be notified through Admit Card which can be downloaded from Dashboard of the portal using existing credentials at the appropriate time.
5. Individual marks of all candidates who appeared in the examination will be available only after the conduct of Stage-II: Skill Test on their Dashboard at www.aiimsexams.ac.in.
6. It is mandatory to appear and qualify in the Skill test for post at Institute where it is explicitly mandated as per published criteria for further consideration in selection process for the said post. It is important to mention that there are posts where skill test is not required in published criteria. Hence, a candidate who appear and qualified in skill test will be provisionally eligible for all post in a group subject to fulfillment of other educational and experience criteria as published. Any candidate fails to appear in skill test or not qualified in skill may be eligible only for posts where skill test is not a mandatory criteria subject to fulfillment of other published criteria for the post. In both cases candidature is always in order of merit.
7. After the conduct of Skill test, a list of provisionally qualified candidates as per the prescribed Scheme of Examination will be called for exercise of choices and its order of preference for online seat allocation of Institute subject to eligibility.
8. Candidates must carefully review their eligibility strictly as per published eligibility criteria for respective applicable category (including PwBD) for the post/institute before exercising their choices. If a candidate is found ineligible at any stage (e.g., due to age, qualification, experience, category certificate or any other conditions), their candidature will be cancelled, even if they have been allocated a seat. In such cases, their selection will be treated as void ab initio.
